RTI Terms Of Use

1. Introduction

These Terms of Use ("Terms of Use") apply to the Round Table International website located at www.round-table.org, and other Round Table International controlled or integrated third party websites, software, platforms, applications, content, products, services and interactive features (collectively "the Site"). The Site, excluding the integrated products (defined below), is owned by Round Table International ("RTI", "us", "we"). Access to and use of the Site is subject to these Terms of Use and all applicable laws. These Terms of Use govern your use and posting on RTI's social media channels.

Please read these Terms of Use carefully. By accessing, using, or browsing, registering for or posting any content on the Site, you ("you," "your," "User," or "Users") accept and agree to these Terms of Use.
